#### 請注意:

- 1. 此表僅限個人使用,如為公司或其他法人申請,請使用W-8BEN-E或W-8IMY。

- 6. 國元証券經紀(香港)有限公司、國元期貨(香港)有限公司,以下統一簡稱"國元", 有權在任何時候要求我司的客戶提供W-8BEN表格簽署原件。
- 7. 若您的身份由他國國籍變更為美國公民或永久居民,請於30天內填寫W-9通知"國 元"。
- 8. 若您的固定居住地址遷移至不同國家,請於30天內填寫新的W-8BEN表格交予"國元"。
